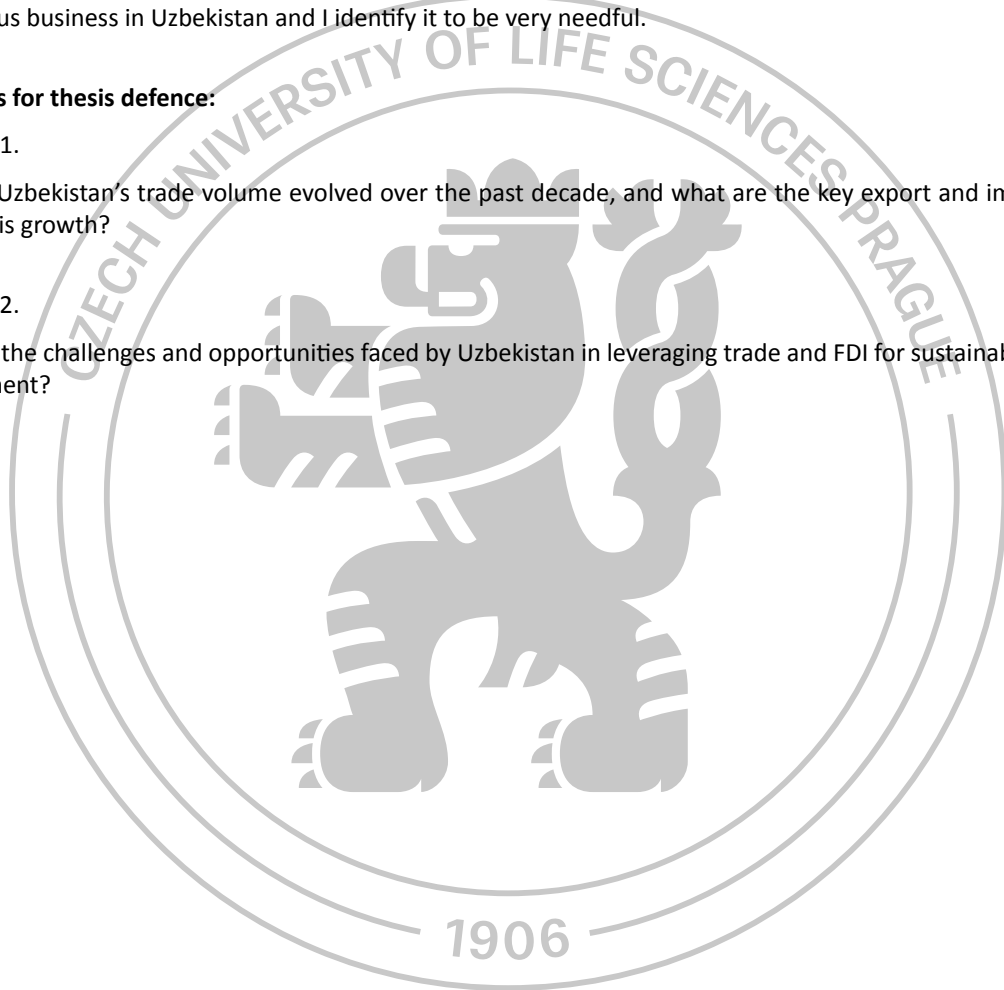
Questions for thesis defence:
