Very good overall analysis of the CSR activities in India society.

The otherwise good quality of the text is reduced by several shortcomings, in particular the absence of a clearly formulated goal of the thesis, many methods used, which are valuable in themselves, but whose potential is not fully utilized, and insufficient presentation of the results of the questionnaire survey.

Questions for thesis defence:

1. Are similar CSR initiatives implemented at the level of small and medium enterprises in India?
2. What was the number and structure of respondents in the questionnaire survey? How it can expand the data found?
