**Other comments or suggestions:**

This thesis examines the impact of mobile applications on crisis management in Nepal after the 2015 earthquake. The study investigates the benefits and barriers of mobile application use for crisis management and analyses the impact of mobile applications on communication, mapping, donations, and information dissemination in Nepal. It also explores the relationship between mobile application use and consumer behavior. The research methodology includes a survey, semi-structured Interviews and the data collected is analyzed and discussed with the aim of conducting a SWOT Analysis. The study identifies the challenges of using mobile applications in Nepal for better crisis management, such as poor digital literacy, infrastructure development, data and security, linguistic factors, and investment. The thesis concludes that mobile applications have significant potential for improving crisis management in Nepal, but several challenges must be overcome to maximize their effectiveness. The study provides valuable insights into the use of mobile applications for crisis management in Nepal and suggests directions for future research.
