Other comments or suggestions:

Despite regular consultations, I have certain reservations about the supervised diploma thesis, which mainly concern the formal requirements of the work (e.g. occasional typos, bad inflection, use of emotionally charged words, etc.). The methodology chapter should have been better elaborated. Comments on the economic analysis are insufficient because it is a time series of 10 years. The evaluation of the student is very often only 1 or 2 paragraphs. It was necessary to describe in detail the economy developed of organization over time and what causes led to the presented values. The conclusions of the work, due to the achieved results of the work, could have been better elaborated. The student describes very briefly the results of her work only in the last paragraph of the conclusions.

Based on the above, I therefore recommend the supervised diploma thesis for defense and rate it as very good.
