| The submitted thesis confronts Victorian attitude to women and the portrayal of various characters in three selected characteristic pieces of literature by Virginia Woolf. In the first part (The Victorian Period, pp. 14-25) the candidate mainly compiled the available data and then in the second part (Feminist Movement, pp. 26-33) outlined the concept and the development of Feminism in its historical context from the beginning to the present as the basis for the analyses of Woolf's writings, and briefly characterized the author. These parts compiled all important data; surprisingly, there is no mention of any links to American feminist movement. The main part of the thesis (Feminism in Selected Works of V. W., pp- 34-65) applied them to the writings. The candidate's method is to characterize the different writings and connect the individual texts with general issues, i.e. just a kind of description with many repeated ideas. Nevertheless, the findings are quite aptly summarized in the Conclusion (pp. 66-69). The primary and secondary sources are well selected and appropriately used. The standard of language and style is good throughout (with a few exceptions, e.g. pp. 13, 38, 58). The formal aspects of the thesis, references and bibliography comply with the requirements. In conclusion, the candidate has manifested her ability to produce a study fulfilling all the necessary standards and requirements for a Bc. thesis in the field. | |
