1. INTRODUCTION

Traditional businesses and institutions are turning to e-commerce to help them break down geographical and temporal barriers, allowing them to provide a more customized service to their customers. E-commerce has spawned a slew of innovative new businesses as a result of these efforts. E-commerce and the software that supports the innovation have changed dramatically over the last four decades and continue to do so. Despite the fact that e-commerce is no longer just about online purchasing, the majority of e-commerce solutions are focused on developing web stores. E-commerce platforms that allow developers to access and process the data from any application are the primary goal of the company. To put it another way, ecommerce is the practice of purchasing and selling items online. Internet marketing, electronic payments transfer, and mobile commerce are just a few of the many advantages of doing business online. Sellers participating in online marketplaces where many transactions involve third parties. Developers will be able to utilize this implementation as a starting point for creating their own custom online stores. In 1979, British inventor Michael Aldrich developed teleshopping, an early type of online shopping, in this technique, a telephone connection was used to connect the television to a shopping transaction program. In 1984, Jane Snowball became the first-ever online home shopper, purchasing goods from the Tesco store in London. The main aim of this thesis is to develop a prototype which will be used to optimize Ecommerce web application. The advantages of applications contain faster purchasing process, setting up a store and product listings, reduced expenses, cost-effective marketing and advertising, The ability to adapt to changing needs of the clientele, there is no height restrictions, product and cost comparisons are also included, increased responsiveness to the needs of customers and the market and there are a variety of ways to pay. Development of ecommerce site in not the only task do in e-commerce business, there are many other tasks such maintenance and optimization also have importance like building and designing a website. To perform these tasks simultaneously is an important point. There are many third party entities and company which provides facility for website development while how far these services would be successful it is not certain. Building a customized e-commerce website is a good practice so that maintenance and optimization could also be possible for website in order to manage and save application from system failure.

1.1 Motivation

In the future, e-commerce will require more flexible solutions, and it's safe to say that custom software won't be able to meet those needs. It makes more sense to provide merchants with a robust and flexible platform on which to build their own products rather than prebuilding a finished product on top of an e-commerce platform that can then be customized to meet the needs of individual merchants (Laudon et al., 2013).

SPHERE.IO's development team was inspired by that question when they came up with this new commerce platform-as-a-service. E-commerce platforms that allow developers to access and process commerce data from any application are the primary goal of the founders of this company.




Figure 1.1 SPHERE.IO-based Java web application diagram.

Regardless of the programming language or framework used to develop the application, the SPHERE.IO backend system may be accessed via a RESTful web API (Luiz Escoriza, 2014). Open-source Java client libraries were the first of several to be developed to make development more user-friendly. The SPHERE.IO Play SDK, a web application development toolkit for the Play framework, was also created (Figure 1.1).

An e-commerce application is needed to assess the benefits and drawbacks of this platform because no system has ever been constructed with this platform except for a few modest testing sites. Another requirement is to have a bootstrap project whose code can be reused by other projects, be they internal or external.

1.2 Objectives

There are two primary goals of this project, and they are intertwined. One objective is to analyze the e-commerce web application and second is to provide information about the tools based on research and on how to use those tools. Students cum developers will be able to utilize this implementation as a starting point for creating their own custom e-commerce website. Additional documentation will be provided in the form of GitHub source code links, where users can visit and take an idea from source code and implement as per their specific requirement. Better alternatives will be provided to the user in future work whenever possible with the purpose of improving the original concept.

1.3 History of e-commerce

For decades, e-commerce has been steadily increasing its importance in the commercial context as the standard known as EDI was developed in the mid-1960s and began to replace traditional mail and fax documents. British inventor Michael Aldrich developed tele marketing, an early type of online shop, in 1979, and termed it as teleshopping. Telephone lines were used to connect a real-time transaction processing system with an online shopping application to a home television. For communication, it made use of a residential telephone connection and a modem chip originally developed for the prestel system. As a result, televisions were being used as real-time terminals in Aldrich's system despite the fact that the Prestel data transmission protocol was not being fully utilized (Tian et al., 2006).

For the first time in operations, Thomson Travel Group was able to purchase Michael Aldrich's Redifon Computers' online buying system (Figure 1.2) in 1981. (a subsidiary of the Thomson Corporation). Although Aldrich initially designed his system for B2C online shopping, the initial demand was for B2B online shopping for holiday travel, vehicles and spare parts, sales, loan finance and credit scores, despite his system working from a low-cost domestic television and using a domestic telephone line. (Dos Santos et al., 2017).

It wasn't until Aldrich's teleshopping system made it to Jane Snowball's house in 1984 and she became the first-ever online home shopper, purchasing goods from the Tesco store in London, United Kingdom (Figure 1.3). To help elderly individuals who couldn't go shopping, she used a social service project in the English city of Gateshead, called the GSS (Gateshead Shopping Service). It worked out great! Two years later, in the English city of Bradford, a considerably larger experiment for the city's most impoverished residents was conducted. Both projects necessitated the use of an early version of the shopping cart system.

Europe has seen the introduction of similar interactive television systems that use telephone lines. French telecommunications company France Telecom developed an online service called Minitel in 1982, and it was by far the most popular and widely used at the time. Only a few B2B transactions were a success with teleshopping in this particular instance, however People were unable to access the technology required for B2C because it was too difficult for them to do so. However, local governments partnered with supermarkets to try out social experiments involving grocery delivery for elderly and disabled residents.

Electronic commerce necessitated an expansion of its customer base beyond the realm of strictly business-to-business transactions. In 1990, when he combined hypertext technology with the Internet to create the World Wide Web, Tim Berners-Lee provided that opportunity [Ber00]. Internet commerce was not permitted even though it was technically possible. A fee based on network usage was instituted in 1991 as a condition of the restriction being lifted. This fee was used to pay for the network infrastructure. When commercial Internet use became completely free in 1995, these restrictions were also eliminated (Kalakota, et al., 1997).

For the first time, in 1994, Netscape released a commercial browser that included the SSL cryptographic protocol. B2C businesses were finally able to thrive in an expanding market thanks to the rise of the internet and a protocol that ensured secure online transactions. Web shops and e-commerce solutions to help merchants sell online began to appear in the early 1990s. Within a year, two of today's largest online retailer companies, Amazon.com and eBay, were born.

A revolution in payment systems was unavoidably a corollary to all of these developments. Mobile payments, online banking, debit and prepaid cards via cell phone are among the many innovations that have entered our daily lives over the last three decades and have had the greatest impact on e-commerce. All of them made it easier to make online payments by increasing the number of payment service providers available. PayPal is one of the most widely used e-commerce payment systems today, handling transactions between merchants and acquirer banks in a secure manner over the Internet.

1.4 Purpose of Study

While building a web application, most important thing is to make sure that users are compelled to spend time on website. The first step is to get to know the customers and their expectation from the website by leveraging gathered historical data from various tools.

The goal is to learn where a user looks when they first land on a homepage so that we can identify key points of interest and focal points. The search for a specific pattern that reflects the differences between the attitude of web pages and the reasons why people favor one site over another is also an important consideration.




Figure 2.1 Business to business block diagram




Figure 2.2 Business to Customer block diagram

It is a type of E-Commerce based on transaction of products and services between consumers only with the help third party who works on commission. Example: You can sell your used product on eBay to another consumer.




Figure 0.3 Consumer-to-Consumer block diagram




Figure 2.3 Consumer-to-Business block diagram

2.3 Factors by which customers start moving towards ecommerce website:

E-commerce transactions are quite different than marketplace shopping. Since two entities in traditional business, negotiations are done face to face among both parties whereas on e-commerce website customer doesn't know about the identity of seller therefore it is the main reason that website should be reliable for customers to increase the traffic on the website. (Le et al., 2017)




Figure- 3.1 home page of GoDaddy website






Figure-3.4 Represents the register page of Stripe payment site. [https://dashboard.stripe.com/login]




Figure-3.5 Represents home page of Stripe site. [https://dashboard.stripe.com/test/dashboard]




Figure-3.6 Represents activating account by going through all given options.




Figure- 3.7 Represents how we can integrate Stripe payment site with WordPress. [https://wordpress.org/plugins/]

With the help of WordPress functionality we can change content, and images on the website, we can add products on homepage and also can change logo of the website by using WordPress options and there is option to change menu as well.




Figure-3.8 represents how we can change content of our website using WordPress Functionality.




Figure-3.10 Represents the functionality by choosing, can add images from gallery.




Figure-3.11 Represents email screenshot for Stripe site.

3.2 Ways to e-commerce website from scratch using languages:

There are following sections comes when we start building any website: Frontend, Backend and Database. These three are the basic for any website development.

Frontend: for frontend website programming, we can use HTML, CSS, JavaScript, Bootstrap as a framework, Angular and Vue Js. Html provides body for the website and CSS responsible for look and feel of the website. For backend we have plenty of programming languages by using we can create backend section of the website. There are few languages like Java, PHP, Python, C, C++, Golang, Ruby, Scala etc. For databases we can we Microsoft SQL, PostgreSQL, MongoDB, AWS, Microsoft Azure, and Apache Cassandra.

In this literature we will mainly focus on Html, CSS and Bootstrap for the frontend, Java for Backend and Apache Cassandra for Database.

3.3 Why to choose above technology stack for development:

Developing any website from scratch provides ability to maintain and optimize the website properly. Html and CSS are very friendly language and by using these technologies results a nice looking website. There are few frameworks by using we can enhance the looks of the website and can have fully responsive website.

Java is an old and most demanded programming language because of its functionality and special properties of OOPs concept. Java is not only an object-oriented programming language, it is also a set of technologies that make software development more rapid and resulting applications more robust and secure. For years Java has been the technology of choice because of the benefits it offers:

- Platform independent
- Ease of use
- Complete library that speed up application development
- Security
- Scalability
- Extensive Industry support (Budi, et al., 2011)

Cassandra is a fully distributed, masterless database, offering superior scalability, and fault tolerance to traditional single-master databases. Cassandra offers a uniquely robust and expressive interface for modeling and querying data. Apart from the following features,

Apache Cassandra has a large user base including some top technology firms such as Apple, Netflix and Instagram, who also provide open-source features. It is being actively developed and has one of largest open source communities with close to 200 contributors and over 20,000 commits. Cassandra has no single point of failure for reading or writing data. Each piece of data is replicated to multiple nodes, but none of these nodes holds the authoritative master copy. All the nodes in a Cassandra cluster are peers without a master node. If a machine becomes unavailable, Cassandra will continue writing data to the other nodes that share data with that machine and will queue the operations and update the failed node when it rejoins the cluster. This means that in a typical configuration, multiple nodes must fail simultaneously for there to be any application - visible interruption in Cassandra's availability.

(Yarabarla, et al., 2017)

There are three main features in database concept called CAP theorem: Consistency, Availability and Partition Tolerance. These are key requirement which you can keep in mind while choosing your database. But at the same time, you can't choose all three key points, you must scarify one. Either you can go with 'consistency and availability' or 'availability and partitioning' or 'partitioning and consistency' you can choose according to your application need. For traditional databases like RDBMS, consistency is the key aspects, and it provides availability as second requirement. If you are okay with sacrificing availability and wants to go with consistency and partition tolerance, we must use database like MongoDB, HBase and Redis. While if your application requirements are partition tolerance and availability, go with database like Cassandra, CouchDB, DynamoDB, Riak.

Let's say if you have records of 1 to 10, it is easily manageable, but when you have records nearly 10 billion, you can't store data in one physical table or in one physical machine, even though you might have capability of storing everything, if you reading sharde and writing. What happens in traditional RDBMS, so in the first there will be a key and then this key has to be searched first, the first operation is you have to do scan huge files and records of particular user, you have everything in one place, scanning that terabytes of records and say 1 billion of records technically will be challenging. So the idea is instead of storing everything in one place in same table, the records can be stored at multiple places.

So we distribute the data and say 1- 3 to one machine, 3 - 4 to second machine and 5 - 6 to third machines and so on. You have chunked or sliced all the records into different physical pattern and distributed them into many physical machines, where you have the smallest setup data section instead of handling everything in a bigger set that is what partitioning is and to do partitioning, there are different techniques what we used to use prior to all this No-SQL offers. People used to have application shards, where application will figure out which server and which location your data should go. Partitioning means you divide your data into smaller chunks instead of working on bigger record set.

Requirements to use Cassandra:

To use Cassandra, basic knowledge of NoSQL technology is required, also Cassandra is very effective database as it is highly consistent to write operations. It is very granular and are replicated according to replication factor so that the data becomes highly available as well on the replication nodes and therefore simultaneous read operations are consistent.

Cassandra is very effective in following scenarios:

- Big data(Billions of records of data have rows and columns)
- Very high velocity random reads and writes.
- Flexible sparse/ wide column requirements
- No multiple secondary Index needs
- Low latency

Use cases:




Figure-3.12 Represents monitoring of application using Cassandra read monitoring matrix.

This graph represents the monitoring of data by Cassandra reader. At different period of the time we can monitor our data to see the traffic on the website and which node having higher read request. In the above diagram 3.12, it's clearly visible the change of strips after few intervals of time. Increment in the strips within certain period show the traffic on application. Using the performance matrix of Cassandra tool, we can analyze the load on the application. This load could be occurred due to two reasons- either multiple batch run at one time or actually customer hitting your application and increasing the traffic. Cassandra read monitor matrix helps to monitor the application and also we can recognize that on different node different traffic is coming, by knowing the information on various node we can analyze the read request coming from different resources. When API called in back end, you can know the number of read and write request and different node in order to manage database. This monitoring tool make the database more manageable and easy to deal with billions of data coming per minute.




Figure-3.14 Showing destination folder of install JDK & JRE.




Figure-3.15 shows editing of environment variable of set JDK path




Figure-3.16 Window of system environment variable.




Figure-3.17 Set JDK bin and JAVA_HOME path.




Figure-3.18 Adding path folder to environment variable.



3.6 Tools that used to analyze and search high volume data:

3.6.1 Elasticsearch:

Elasticsearch is a full-text search engine that's primarily used for searching. It can also be used as a NoSQL database and analytics engine. Elasticsearch is basically schema-less and works in near-real-time. It has a RESTful interface, which helps us to interact with it easily from multiple interfaces. Elasticsearch supports different ways of importing various types of structured or unstructured data; it handles all types of data because of its schema-less behavior, and it's quite easy to scale. We have different clients available in Elasticsearch for the following languages: Java PHP Perl Python .NET Ruby JavaScript.

Its query API is quite robust and we can execute different types of queries, such as boosting some fields over other fields, writing fuzzy queries, or searching on single or multiple fields, along with field search. Applying a Boolean search or wildcard search aggregation is another important feature of Elasticsearch, which helps us to aggregate different types of data; it has multiple types of aggregations, such as metric aggregation, bucket aggregation, and term aggregation.

(Srivastava, et al., 2019)

3.6.2 Logstash:

Logstash is a data pipeline that can take data input from various sources, filter it, and output it to various sources; these sources can be files, Kafka, or databases. Logstash is a very important tool in Elastic Stack as it's primarily used to pull data from various sources and push it to Elasticsearch; from there, Kibana can use that data for analysis or visualization. We can take any type of data using Logstash, such as structured or unstructured data, which comes from various sources, such as the internet. The data can be transformed using Logstash's filter option, which has different plugins to play with different sets of data. For example, if we get an IP address in our data, the GeoIP plugin can add geolocation using that IP address, and in the output, we can get additional information of geolocation, which can then be used in Kibana to plot a map. 


Figure-3.24 Represents the New Relic tool.




Figure-3.26 Represents throughput time.




Figure-3.27 Represents top external services.




Figure-3.28 Represents top external services.




Figure-3.29 Represents heap memory uses.
