**Other comments or suggestions:**

The master thesis is prepared on 57 pages of text. It contains 6 logically consecutive parts. In Part 1 Objectives and Methodology, on page 3, author states goal of diploma thesis – investigate the effects of climate changes on Turkey's agriculture, focusing on three primary objectives as well as three research questions. In Literature review, on pages 5-38, author describes theoretical definition of terms that are related to the issue of the final thesis. Practical part, on pages 39 – 53, should have been much broader in content.

I have following comments on this work:

- the assignment of final thesis is missing in final the thesis. This assignment is listed only in the information system;
- the part of assignment of the final thesis states: Interviews with stakeholders in the agricultural sector in Turkey will be conducted to gain a deeper understanding of the potential economic impacts. This part is absent in the final thesis
- some tables are very large and in my opinion should have been part of the appendixes (Table 4, Table 5, Table 6, Table 7).

**Questions for thesis defence:**

1. Which measures would contribute the most to mitigating the effects of climate changes on agriculture in Turkey?
2. As we can see in Table 4 the share of agriculture in GDP in Turkey is constantly decreasing. What factors caused this decline?
