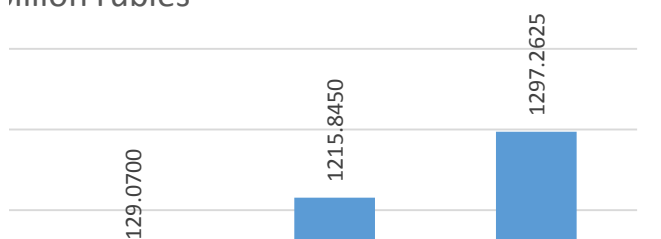
Government support of SME,
in billion rubles, for different entities of the Russian

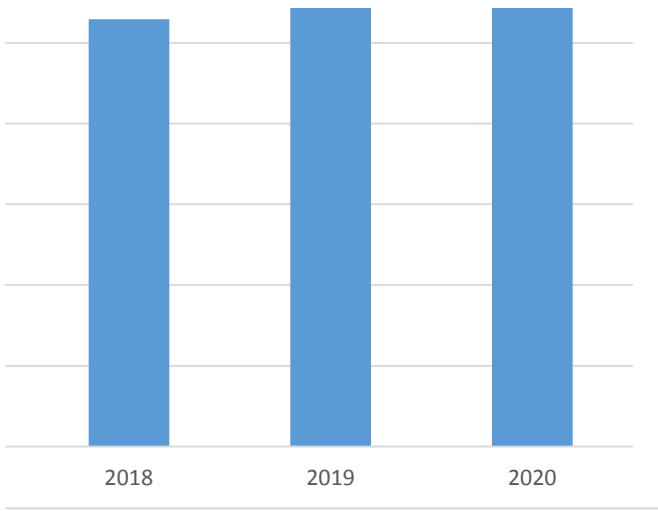


Government support of SME, % of the total investment

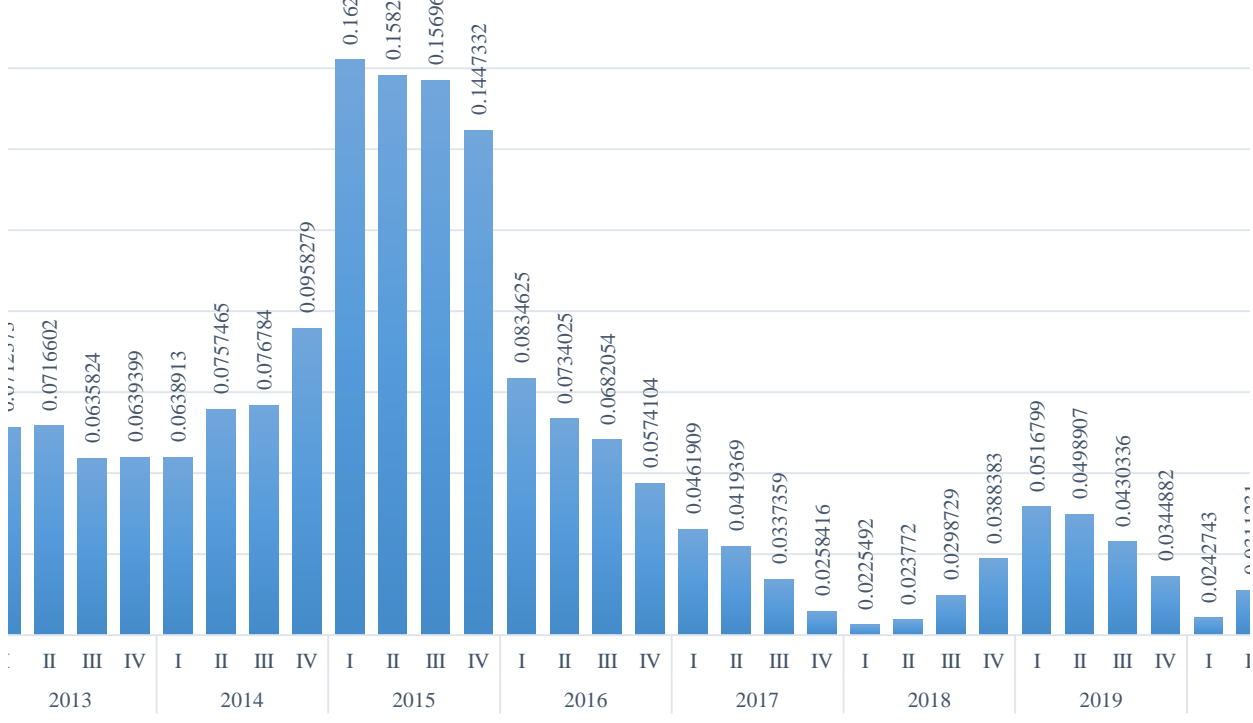

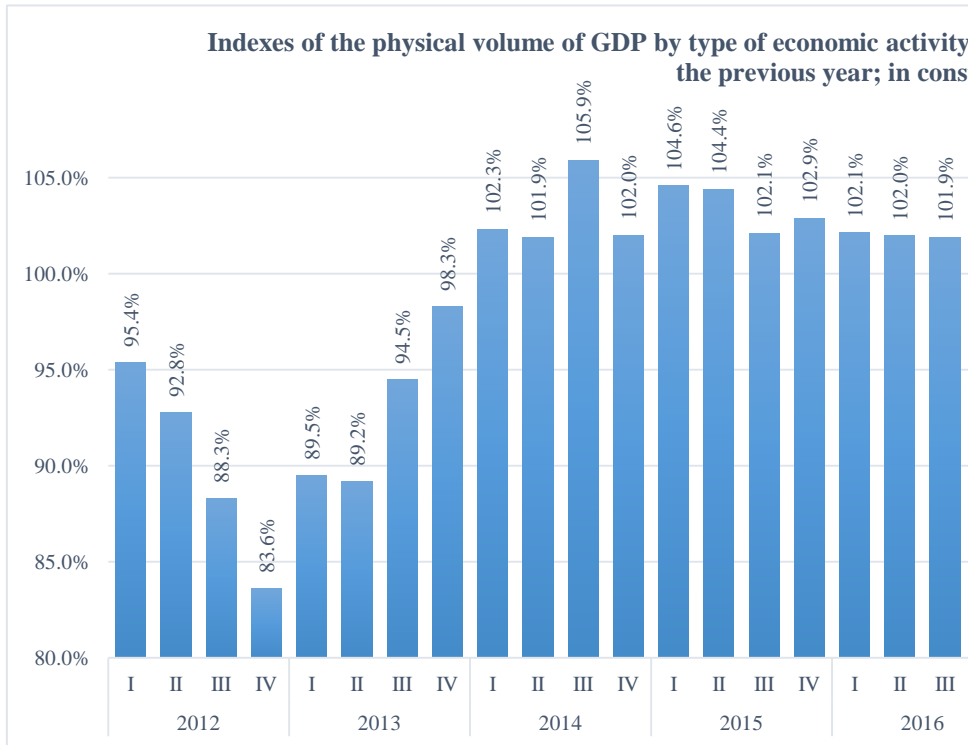
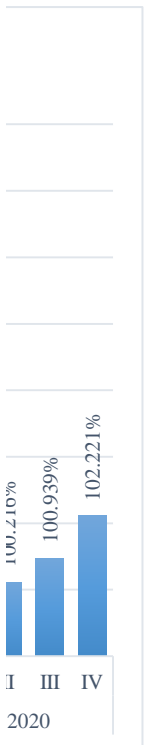
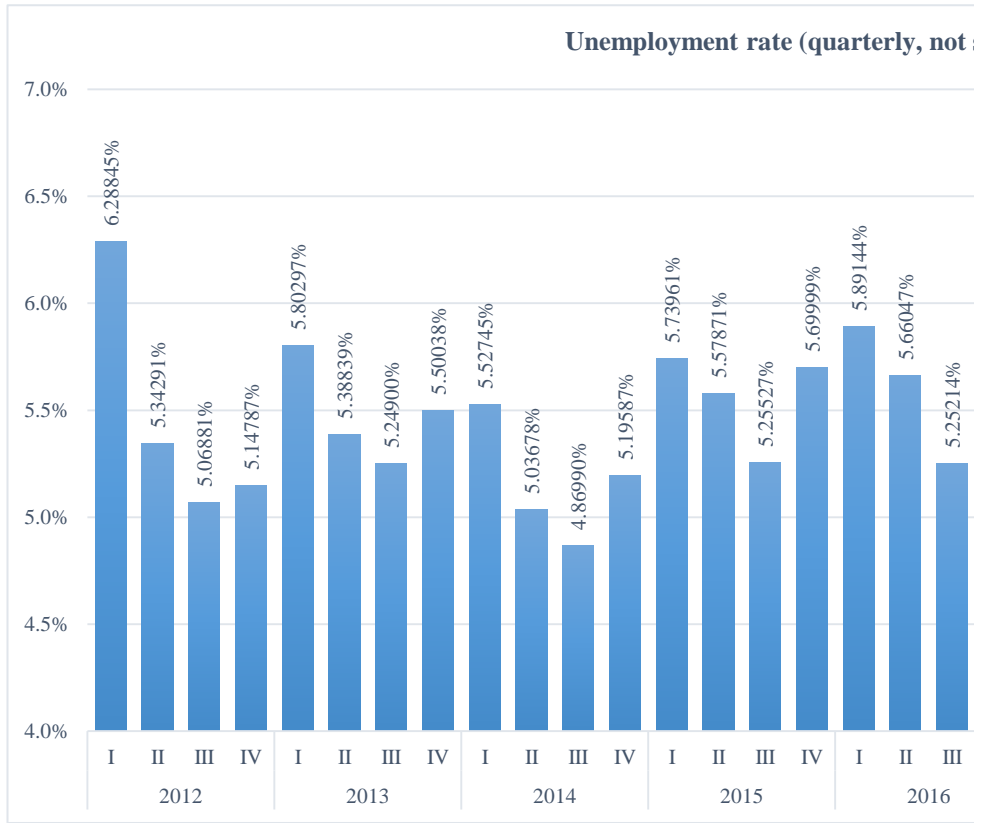


Domestic Producer Prices Index for Russian Federation (quarterly, not seasonally adjusted)

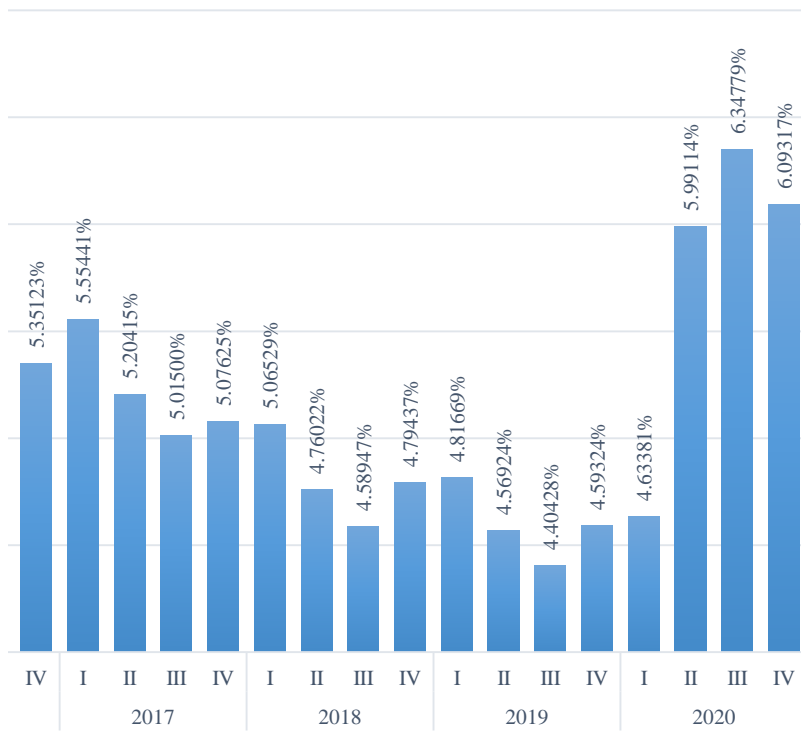


Domestic Producer Prices Index for agriculture for the Russian Federation (annual, as a % of the corresponding period of the previous year)

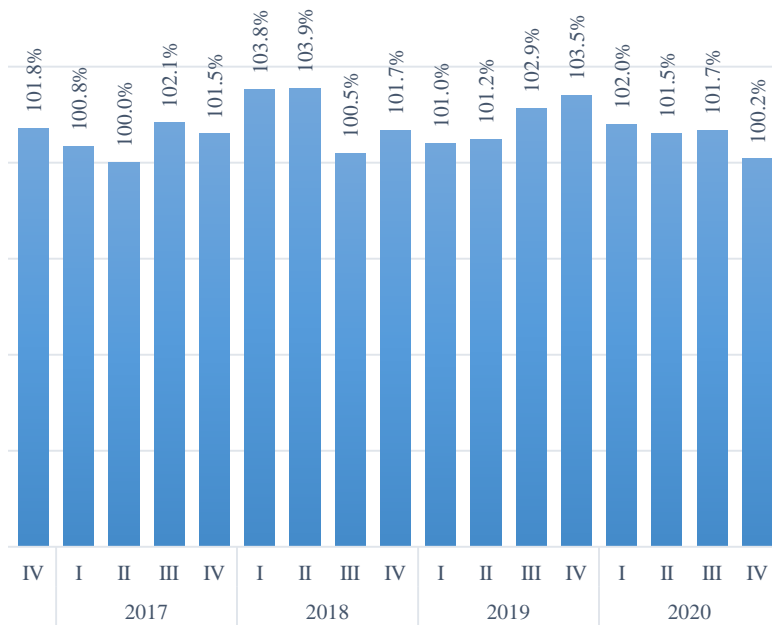
