Other comments or suggestions:

The topic is interesting and relevant, performed research is not deep, basic but still sufficient, the selected methodology allows for addressing the stated aims and goals, the presented analysis and discussion meet, but don't exceed, basic requirements. The thesis looks rather as a quasi-final draft expecting final improvements, reinforcement by references to more current academic literature and a more robust methodological approach. The tenor is not truly academic, it looks rather as a general review. There are many typos and corrections needed. At the same time, it must be recognized that the author attempts to follow an empirical approach and to be practical and instructive. It is pity that the goals were not set more clearly and the top recent relevant literature was not presented. I am confident that with that the author would be able to do a very interesting analysis and to present relevant and strongly supported conclusions.

Questions for thesis defence:

- 1) Do you really believe that more mergers will lead to "more price wars", i.e. why you do not expect a possibly negative impact on competition due to the increased risk of concentration and perhaps even cartel situations?
- 2) Describe in more detail the impact of the described merger on various types of stakeholders and define who are the winners and losers.
- 3) How has the COVID-19 pandemic changed the merger inclination on the Indian market?
