The student focused her thesis on three main goals: The first was to describe and assess the impacts of COVID-19 by sector in selected developing countries (Ethiopia, Zambia, Bosnia, Herzegovina, Moldova, Georgia, and Cambodia). The second objective was to compare these specific impacts, and the third objective was to consider how the coronavirus disease in developing economies has negatively affected developed countries.

Criteria for the selection of these six countries came from the fact the above-mentioned countries were selected by the Ministry of Foreign Affairs CR as priority countries of the CR for cooperation in the period 2018-2023.

The student has built the thesis from the seven operational chapters. particularly from the literature review, objectives of the thesis, methodology, results, discussion, conclusion plus appendix.

On the bases of the collection of data (questionnaires), treatment, and appraisal of data the student created the results and deliverables of the study.
