**Other comments or suggestions:**



The content of thesis is not adequate to the topic of the thesis. In the chapter Objectives there are not formulated aims in an appropriate way. In the methodology chapter there are missing references to regression methods. The formal requirements, for instance citation norms, reference list are not formulated in a correct way. The list of tables, formulas, charts and figures is missing. In the chapter conclusion there are subjective phrasing, for instance "I believe".

The Whole thesis should be rewritten. The author has to make an interconnection between topic of thesis and structure of the thesis.

Due to the reasons I do not recommend the thesis for defence.
