"Impact of population growth on the economy of India (Uttar Pradesh state – focus on selected economic sectors). "

Obtaining realistic data from this area has been difficult, especially since some official government sources about data related to the thesis topic are sometimes different from reality.

The student prepared his master's thesis according to the regulations, models, and manuals issued by FEM CZU.
